Seemingly innocuous names like Operation Leprechaun and Project Tradewinds, together with an array of intelligence and surveillance activities, formed a pattern of abuse that threatened the foundations of American political culture. In one of the most powerful and sobering passages of the book, Mr. Andrew chronicles the IRS's Special Service Staff, which carried out activities that were more extensive and intrusive than Nixon's infamous Enemies List?yet received scant coverage in the media. He also offers important revelations about Nixon's ties to organized crime through Bebe Rebozo. *Power to Destroy* is a shocking analysis of how political influence has corrupted the IRS, and how the agency's own crusade for secrecy hides its operations from public scrutiny, even from congressional committees responsible for overseeing its activities.
